

## Sunrise School Community Council Minutes

Welcome – Those in attendance were recognized and thanked for taking time out of their schedules to be there, our last meeting of the year.

1. Approve minutes from previous meeting—A motion was made by Marc Hone to approve the minutes. No discussion was needed. Rochelle called for a vote. Minutes were unanimously approved.
2. SNAP—See the 2019-20 Community Concerns schedule. We took a few minutes to review the schedule before Rochelle asked for comments. Rochelle brought some plats from the city so we could prioritize what the most important sidewalk improvements are on 1700 East. If we requested a sidewalk on 1700 East and 11245 S., on the northwest corner, it very likely could be approved. We made that location as Priority #1. Bob Bolds has been instrumental, along with Rochelle, in getting the city involved. City mentioned adding an accessibility ramp on 1700 East around 10980 South. SCC chose the priority of the remaining locations on the schedule to be recommended for improvements. We are working with Kevin Riddle at Sandy City.
3. TSSA—Teacher Student Success Act—Margaret was under the impression that we can spend the TSSA funds the same as the Land Trust funds. However at the latest leadership meeting, they were told that the law was written that all the money needed to be spent on the students. Money cannot be spent on technology, etc. Can be spent on Aides, substitutes, reducing class sizes, etc. We will use TSSA funds for aides and amend the Land Trust plan in the fall and use those funds for technology instead of aides as was originally submitted. Margaret passed out a summary of the TSSA plan that the BLT helped her develop. We reviewed and discussed in depth the details of the plan. We all ultimately agreed with the proposed spending plan of the TSSA funds and signed the proposed plan. See TSSA proposed plan document dated May 20, 2019.

UPDATE: On May 21, Margaret received additional information regarding the spending of the TSSA funds. We will be allowed to spend some of the funds on technology (computers etc.). The proposed plan was revised to leave the aides in the Land Trust plan. We will spend the TSSA funds on a few aide hours, Salta curriculum and technology. There is no longer a need to revise the Land Trust plan in the fall.

4. Spring CBM Data—We reviewed the 2018-2019 CBM data with the Spring results. Results show exciting growth and improvement with our students.
