



Sunrise Elementary School: End of Year LAND Trust Summary Report

*Sunrise Elementary School Community Council was pleased to be able to spend **\$80,400** of LAND Trust funds on Sunrise Eagles for the **2019 - 20** school year.*

Sunrise Elementary School Community Council was pleased to be able to spend **\$80,400** of LAND Trust funds on Sunrise Eagles for the 2019 - 20 school year. It was determined that funds should be spent on reading, math, and technology. To increase reading and math achievement, students were identified as performing below benchmark on Acadience testing. Students identified received daily intervention support from intervention assistants under the direction of the achievement coach. Most of the allocated School Land Trust funding, **\$45,000**, was used to hire three assistants to provide reading interventions and two assistants to provide math interventions. A total of **\$2,000** was spent on substitutes. They were utilized so teachers could participate in coaching cycles to improve their capacity in reading whole group and skill-based instruction. Literacy online programs, costing **\$12,400**, were purchased to be in used in skill-based instruction and literacy practice stations. K - 1st grade teachers prefer using iPads with their Eagles. iPads were purchased for skill-based instruction and literacy practice stations for **\$21,000**. Sunrise is 1:1 with iPads and Chromebooks across the school. The Sunrise SCC sees our LAND Trust Plan resources as a crucial component of our student achievement. *It also helps that Sunrise teachers are simply the BEST!*

Sunrise's LAND Trust Goals for 2019 - 2020

ENGLISH LANGUAGE ARTS

85% of K - 3rd grade students at Sunrise Elementary will reach proficiency on Acadience Reading measures by Spring 2020. 80% of 4th and 5th grade students will reach proficiency on Reading Inventory measures by Spring 2020.

Due to COVID closure, Sunrise does not have spring Acadience reading data. However, Sunrise can use winter Acadience reading data to show progress for the 2019 - 2020 school year. 3rd grade neighborhood fall Oral Reading Fluency was 83% proficient and winter Oral Reading Fluency was 83% proficient. 4th grade neighborhood fall Reading Inventory was 54% proficient and winter Reading Inventory was 64% proficient. 5th grade neighborhood fall Reading Inventory was 64% proficient and winter Reading Inventory was 74% proficient. 3rd - 5th grade SALTA was 100% proficient on both fall and winter reading assessments.

MATHEMATICS

By the Spring 2020, 86% of students at Sunrise Elementary will perform at a proficient level on Mathematics District Wide Standards Based Assessments.

Due to COVID closure, Sunrise does not have spring Districtwide Standards Based Assessments Mathematics data. However, Sunrise can use winter Acadience math data to show progress for the 2019 - 2020 school year. 3rd grade neighborhood fall Mathematical Concepts and Applications was 82% proficient and winter Mathematical Concepts and Applications was 83% proficient. 4th grade neighborhood fall Mathematical Concepts and Applications was 68% proficient and winter Mathematical Concepts and Applications was 88% proficient. 5th grade neighborhood fall Mathematical Concepts and Applications was 74% proficient and winter Mathematical Concepts and Applications was 86% proficient. 3rd - 5th grade SALTA was 100% proficient on both fall and winter Mathematical Concepts and Applications.
